Key inclusion & exclusion criteria

Inclusion criteria: Subjects with any type of stress-related symptomatology, over 18 years old.
Exclusion criteria: Subjects with psychiatric symptoms-pathologies, drugs dependence or aged less than 18 years of age were excluded.

Age minimum: 18 Years

Gender: Both males and females

Health Condition(s) or Problem(s) studied

Stress, Stress-related hyperactivity and acceleration.

Intervention(s)

The intervention comprises: A cycle of Neuro Psycho Physical Optimization (NPPO) with Conveyer of Modulating Radiance (CMR therapy). The CMR is a biomedical radiofrequency instrument. The protocol used, called Neuro Psycho Physical Optimization (ONPF), involves the application of a probe of the CMR on specific points of the auricular pavilion for an activation time of roughly 500 mms. The ONPF protocol is

activated in a precise sequence on seven auricular points. The protocol envisages 18 sessions of ONPF treatment on alternating days, for eight (8) weeks. Assessment, at baseline and at the end of treatment, with Psychological Stress Measure Test (validated in Italian).

Primary Outcome(s)

To test with Psychological Stress Measure if the use of the Conveyer of Modulating Radiance (CMR) - is effective in reducing the subjective perception of stress and stress-related hyperactivity and acceleration.

Secondary Outcome(s)

Wellbeing - Neuro Psycho Physical Optimization.
